CONTRACT AGREEMENT

WHEREAS Bids have been accepted by the Administrator Municipal Committee Daska for a contract cost of Pak Rs. 82,059,016 (Eighty two million fifty nine thousands sixteen rupees only) for the construction & completion of Rehabilitation of 36" I/D damaged sewer line along stadium road in Daska City (As per scope of work and terms & conditions prescribed in the Bidding Documents) as well as possible new and ancillary works associated therewith which have to be executed in accordance with the contract document, and the Bid by the contractor for the construction and completion of such works including defect removal during Defect Liability Period (DLP) has been accepted by the Employer.




